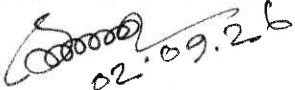

Office Order

This is to notify that the Bangladesh Open University (BOU) is hereby extending Study Leave to **Ms Mamtaz Begum**, Joint Director (Monitoring), Planning & Development Division of Bangladesh Open University for a period of 01 (one) year to undertake PhD Programme under UGC PhD Scholarship at the Department of Entomology, Sher-e-Bangla Agricultural University, Dhaka, as per decision of the 108th meeting of Standing Committee for Advanced Studies, Training and Research of BOU held on 10 August 2026 on the following terms and conditions:

5. That her service during her study leave will be governed by BOU rules;
6. BOU will not bear any expenses for her said study at the Sher-e-Bangla Agricultural University, Dhaka;
