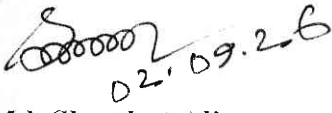

Office Order

11. That his service during his study leave will be governed by BOU rules;
12. BOU will not bear any expenses for his said study at the Bangladesh University of Professionals, Dhaka;
